- 12. Improve control and choice of companies to which to contract work, selecting and promoting the development of suppliers, contractors in accordance with the principles of this policy and committing them to conduct themselves in a manner consistent with it;
- 13. Carry out checks, inspections and audits to identify any situations of non-compliance with the requirements of the occupational health and safety management system;

- 15. Ensure a reliable and comprehensive system for collecting the data needed to run the management system;
- 16. periodically review of the policy and application of the occupational health and safety system to assess its correctness and effectiveness with a view to continual improvement.
